Definitions

Age Band

Derived from date of birth declared by the applicant, age is aligned with the cut off points for school/college cohorts within the different administrations of the UK. Defining ages in this way matches the assignment of childrento school cohorts. For applicants outside of the UK the cohort cut off for England and Wales has been used. Age then is grouped in the following bands: '17 and under', '18', '19', '20', '21and Over'. Please note: if the derived age is outside of the range 11-100 then it is set to 18 by default.

Deadline
