









A.16 Technical notes and definitions

Applicants have been able to submit applications for 2015 courses since early September.

15 October is the 'equal consideration' deadline for Medicine/Dentistry/Veterinary courses and courses at the universities of Oxford and Cambridge.

This statistical release covers applicants that have applied for courses with a 15 October deadline and is a near complete measure of the demand for the courses covered by the deadline.

Counts of the number of applicants reported have been rounded to the nearest 10 applicants, this may result in instances where totals do not equal the sum of the components. Proportional changes have been rounded to the nearest whole percentage point.

Applicants to courses in Northern Ireland are not shown to avoid disclosing figures for individual providers.

Age

This statistical release uses country-specific age definitions which align with the cut off points for school/college cohorts within the different administrations of the UK. For England and Wales ages are defined on the 31 August, for Northern Ireland on the 1 July and for Scotland on the 28 February the following year. Defining ages in this way matches the assignment of children to school cohorts. For applicants outside of the UK the cohort cut off for England and Wales has been used.

Applicants

A person who has made an application in the UCAS system during the cycle reported, this includes those who submit applications for deferred entry.

Country of institution

An applicant may be counted once for each institution country they have applied to. If an applicant has applied to institutions in multiple countries then the applicant is counted once within each country of institution applied to.

Domicile

Declared area of permanent residence. The Channel Islands and the Isle of Man have been assigned as 'Not EU'.

First time applicant

An applicant that did not apply to the UCAS scheme in the previous cycle.

Reapplicant

An applicant that applied to the UCAS scheme in the previous cycle.
